ORDINANCE NO. 11-12

AN ORDINANCE AUTHORIZING THE GRANT OF INDIVIDUAL FINANCIAL INCENTIVES IN THE AMOUNT OF FIFTEEN THOUSAND PESOS (PhP15,000.00) EACH TO ALL PLANTILLA OFFICIALS AND EMPLOYEES OF THE CITY GOVERNMENT OF BAGO FOR THEIR EXEMPLARY COLLECTIVE HARD-WORK AND EXCELLENT PERFORMANCE IN PUBLIC SERVICE THAT EARNED THE CITY SIX RECOGNITIONS IN THE DILG'S 2011 REGIONAL SEARCH FOR EXCELLENCE IN LOCAL GOVERNANCE (EXCELL AWARD), IN VIEW OF RESOLUTION NO. 001 SERIES OF 2011 OF PROGRAM ON AWARDS AND INCENTIVES FOR SERVICE EXCELLENCE (PRAISE) COMMITTEE. THE TOTAL AMOUNT OF THIRTEEN MILLION THREE HUNDRED FIVE THOUSAND PESOS (PhP13,305,000.00) SHALL BE CHARGEABLE AGAINST PRODUCTIVITY ENHANCEMENT INCENTIVES, GENERAL FUND ANNUAL BUDGET, CALENDAR YEAR 2011.
