ORDINANCE NO. 12-03

**AN ORDINANCE AMENDING SECTION 1 OF CITY ORDINANCE NO. 4,
SERIES OF 1995.**

Explanatory Note:

WHEREAS, Section 1 of City Ordinance No. 9, Series of 1994 of Bago City prohibits the manufacture or making of pyrotechnics within one hundred (100) meters radius of houses and residential buildings;

WHEREAS, said Ordinance was subsequently amended to conform to Section 7 of R.A. NO. 7183 entitled: "**AN ACT REGULATING THE SALE, MANUFACTURE, DISTRIBUTION AND USE OF FIRECRACKERS AND OTHER PYROTECHNIC DEVICES**" which authorize the designation by the local government unit of a zone where a manufacturing complex may be established provided that the said zone should be 300 meters away from residential areas;

WHEREAS, in order to effectively enforce the above-quoted ordinances there is a need to identify that zone/place in Barangay Poblacion, Bago City, where sale, distribution and use of firecrackers and other pyrotechnic devices may be displayed or sold.

NOW THEREFORE, on motion of Sangguniang Panlungsod Member Allan C. Galunan, duly seconded by Sangguniang Panlungsod Member Eamon Gabriel V. Matti, the Sangguniang Panlungsod as a whole:

Be it ordained by the Sangguniang Panlungsod of the City of Bago, that:

SECTION 1. AMENDATORY CLAUSE. – Section 1 of Ordinance No. 4, Series of 1995, otherwise known as "AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 9, SERIES OF 1994 is accordingly amended to read as follows:

"Section 1 - No person, natural or juridical, shall make, manufacture or sell pyrotechnics within a radius of three hundred (300) meters away from residential areas.

In so far as Barangay Poblacion is concerned, a sole and exclusive zone for the sale and distribution of firecrackers and pyrotechnic materials is hereby established along Bantayan Boulevard, Fifty (50) meters after the Gulayan Ng Barangay of Barangay Poblacion going seaward."

SECTION 2. REPEALING CLAUSE. – All ordinances, resolution, rules and regulations which are inconsistent with the provisions of this ordinance are hereby repealed.


SECTION 3. EFFECTIVITY CLAUSE. - This Ordinance shall take effect upon its approval.
