ORDINANCE NO. 13-01

AN ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION FOR OTHER MAINTENANCE AND OPERATING EXPENSES OF THE OFFICE OF THE CITY MAYOR THE AMOUNT OF ONE HUNDRED TWENTY FIVE THOUSAND THREE HUNDRED FORTY EIGHT PESOS AND THIRTY FIVE CENTAVOS (PhP125,348.35) REPRESENTING THE CITY SHARE FOR THE INSURANCE PREMIUMS OF BARANGAY TANODS AND BARANGAY OFFICIALS OF 24 BARANGAYS FOR CALENDAR YEAR 2012 AND THE AMOUNT OF THREE THOUSAND TWENTY THREE PESOS AND EIGHTY THREE CENTAVOS (PhP3,023.83) REPRESENTING TELEPHONE BILL OF THE CITY HEALTH OFFICE FOR THE MONTH OF NOVEMBER 2012, CHARGEABLE AGAINST THE CURRENT APPROPRIATION FOR TELEPHONE EXPENSES-LANDLINE, IN VIEW OF THE CLOSING OF THE BOOKS OF ACCOUNTS.

On motion of SP Member Bernadette M. Somcio, duly seconded by SP Member Loreto N. Cauntoy, the Sanggunian

Be it ordained by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. The authority of the City Treasurer to charge against Current Appropriation for Other Maintenance and Operating Expenses of the Office of the City Mayor the amount of One Hundred Twenty Five Thousand Three Hundred Forty Eight Pesos and Thirty Five Centavos (PhP125,348.35) representing the city share for the Insurance Premiums of Barangay Tanods and Barangay Officials of 24 Barangays for calendar year 2012 and the amount of Three Thousand Twenty Three Pesos and Eighty Three Centavos (PhP3,023.83) representing telephone bill of the City Health Office for the month of November 2012, chargeable against the current appropriation for Telephone Expenses-Landline, in view of the closing of the books of accounts, is hereby approved.

SECTION 2. This Ordinance shall take effect upon its approval.
