**ORDINANCE NO. 13-05**

AN ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION FOR TELEPHONE EXPENSES-LANDLINE OF THE BAC SECRETARIAT OFFICE THE AMOUNT OF SIX THOUSAND SEVEN HUNDRED FIFTY PESOS AND EIGHTY THREE CENTAVOS (P6,750.83) REPRESENTING THE TELEPHONE BILL FOR THE PERIOD AUGUST 15, 2012 AND THE AMOUNT OF NINE HUNDRED NINETY NINE PESOS (P999.00) REPRESENTING THE INTERNET BILL OF THE PHILIPPINE NATIONAL POLICE FOR THE PERIOD NOVEMBER 26, 2012-DECEMBER 25, 2012, CHARGEABLE AGAINST THE CURRENT APPROPRIATION FOR INTERNET EXPENSES.

Be it ordained by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. The authority of the City Treasurer to charge against Current Appropriation for Telephone Expenses-Landline of the BAC Secretariat Office the amount of Six Thousand Seven Hundred Fifty Pesos and Eighty Three Centavos (P6,750.83) representing the telephone bill for the period August 15, 2012 and the amount of Nine Hundred Ninety Nine Pesos (P999.00) representing the internet bill of the Philippine National Police for the period November 26, 2012-December 25, 2012, chargeable against the current appropriation for Internet Expenses, is hereby approved.

SECTION 2. This Ordinance shall take effect upon its approval.
