ORDINANCE NO. 15-06

AN ORDINANCE AMENDING SECTION 7, IV OF ORDINANCE NO. 13-07, SERIES OF 2013 OTHERWISE KNOWN AS THE ORDINANCE REGULATING THE OPERATION OF MOTORIZED TRICYCLES THE GRANTING OF FRANCHISE FOR THE OPERATION THEREOF WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF BAGO AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

PRELIMINARY STATEMENTS

WHEREAS, on May 29, 2013 this August Body enacted Ordinance No. 13-07 otherwise known as the ORDINANCE REGULATING THE OPERATION OF MOTORIZED TRICYCLES THE GRANTING OF FRANCHISE FOR THE OPERATION THEREOF WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF BAGO AND PROVIDING PENALTIES FOR VIOLATION THEREOF;

WHEREAS, this Ordinance allocates the number of units to be allowed for issuance of franchise in every tricycle routes in the city;

WHEREAS, IV of Section 7 of Ordinance No. 13-07, Series of 2013 provided 90 units for Brgy. Busay-Poblacion Area where TRICYCLE OPERATORS' AND DRIVERS' ASSOCIATION OF BUSAY, INC. (TRODAB) operates;

WHEREAS, there is an increasing volume of passengers in their area of operation which rendered the present number of tricycles insufficient to fully cater the passengers' demand;

WHEREAS, recognizing this need, the Sangguniang Barangay of Brgy. Busay had enacted Resolution No. 2015-05 which seeks the approval of this August Body for the amendment of Ordinance No. 13-07 particularly Section 7, IV which will give TRODAB additional number of tricycle units;

WHEREAS, after a thorough consultation with the stakeholders, it was revealed that the Busay-Poblacion Area can accommodate an additional of 20 more units on top of the 90 existing units stated in Ordinance No. 13-07;

NOW THEREFORE, on motion of Sangguniang Panlungsod Member Allan C. Galunan, duly seconded by Sangguniang Panlungsod Members Jorge A. Araneta and Danilo U. Famoso, be it enacted by the Sanggunian Panlungsod, that:

Section 1. ***Amendatory provision.*** - SECTION 7, IV of Ordinance No. 13-07, series of 2013 is hereby accordingly amended to read as follows:

“IV.

AREA : ***Busay-Poblacion area***

Number of units : ***110***


Associations : ***TRODAB – Tricycle Operators' and Drivers' Association of Busay Association***

Route : ***From Brgy. Busay to terminal in Bago City Public Market, Brgy. Poblacion & vice versa, excluding Crossing Camatis, Sampinit Proper, Pinanuy-an, Sibud;”***

Section 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.
