ORDINANCE NO. 15-13

AN ORDINANCE AMENDING SECTION 7, XVII OF ORDINANCE NO. 13-07, SERIES OF 2013 OTHERWISE KNOWN AS THE ORDINANCE REGULATING THE OPERATION OF MOTORIZED TRICYCLES THE GRANTING OF FRANCHISE FOR THE OPERATION THEREOF WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF BAGO AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

PRELIMINARY STATEMENTS

WHEREAS, on May 29, 2013 this August Body enacted Ordinance No. 13-07 otherwise known as the ORDINANCE REGULATING THE OPERATION OF MOTORIZED TRICYCLES THE GRANTING OF FRANCHISE FOR THE OPERATION THEREOF WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF BAGO AND PROVIDING PENALTIES FOR VIOLATION THEREOF;

WHEREAS, this Ordinance allocates the number of units to be allowed for issuance of franchise in every tricycle routes in the city;

WHEREAS, XVII of Section 7 of Ordinance No. 13-07, Series of 2013 provided 80 units for Barangay Bacong Area;

WHEREAS, there is an increasing volume of passengers in their area of operation which rendered the present number of tricycles insufficient to fully cater the passengers' demand;

WHEREAS, recognizing this need, the Sangguniang Barangay of Barangay Bacong and Barangay Ma-ao have enacted their respective Resolutions which seeks the approval of this August Body for the amendment of Ordinance No. 13-07 particularly Section 7, XVII which will give the Bacong Area additional number of tricycle units;

WHEREAS, after a thorough consultation with the stakeholders, it was revealed that the Bacong Area can accommodate an additional of 4 more units on top of the 80 existing units stated in Ordinance No. 13-07;

NOW THEREFORE, on motion of Sangguniang Panlungsod Member Allan C. Galunan, duly seconded by Sangguniang Panlungsod Members Cleo F. Gaudite, Bernadette M. Somcio, Federico A. Matti, be it enacted by the Sanggunian Panlungsod, that:

Section 1. Amendatory Provision. - SECTION 7, XVII of Ordinance No. 13-07, series of 2013 is hereby accordingly amended to read as follows:

“XVII.

AREA : *Bacong area*

Number of units : **84**


Associations : **MABASATODA – MAAO BACONG SANDUNGAO Tricycle Operators’ and Drivers’ Association**

Route : *From Brgy. Bacong to Brgy. Maa & vice versa;”*


Section 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.
