ORDINANCE NO. 16-05

AN ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION OF THE BAGO CITY HOSPITAL FOR SALARIES AND WAGES-REGULAR, THE SALARY DIFFERENTIAL OF MARIE GRETZEN D. SUBAYCO FOR PERIOD OF DECEMBER 22-31, 2015 IN THE AMOUNT OF SEVEN THOUSAND ONE HUNDRED EIGHTY EIGHT PESOS (P7,188.00) AND LIFE AND RETIREMENT INSURANCE PREMIUMS IN THE AMOUNT OF EIGHT HUNDRED SIXTY TWO PESOS AND FIFTY SIX CENTAVOS (P862.56), IN VIEW OF THE CLOSING OF BOOK OF ACCOUNTS FOR CALENDAR YEAR 2015.

Be it ordained by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. The authority of the City Treasurer to Charge against Current Appropriation of the Bago City Hospital for Salaries and Wages-Regular, the Salary Differential of Marie Gretzen D. Subayco for period of December 22-31, 2015 in the amount of Seven Thousand One Hundred Eighty Eight Pesos (P7,188.00) and Life and Retirement Insurance Premiums in the amount of Eight Hundred Sixty Two Pesos and Fifty Six Centavos (P862.56), in view of the closing of book of accounts for Calendar Year 2015, is hereby approved.

SECTION 2. This Ordinance shall take effect upon its approval.
