RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF AGRICULTURE RFU-VI AND THE CITY GOVERNMENT OF BAGO FOR THE IMPLEMENTATION OF THE DIVERSIFIED FARMING THRU ORGANIC AGRICULTURE UNDER THE GRASSROOTS PARTICIPATORY BUDGETING PROCESS (GPBP) PROGRAM AMOUNTING TO ONE MILLION TWO HUNDRED THOUSAND PESOS ONLY (PHP 1,200,000.00).
