RESOLUTION NO. 15-086

RESOLUTION SUSPENDING THE ONE-WAY-IN ONE-WAY-OUT POLICY IN SO FAR AS THE BLUE TOP TRICYCLES, NAMELY: MEMBERS OF BACTODA, CAPTODA AND PBLTODA COVERING THE HIGHWAY FROM DON JORGE L. ARANETA TO POBLACION AND VICE VERSA.

WHEREAS, in his privilege speech during the regular session of the August Body on February 25, 2015, Hon. Cleo F. Gaudite tackled the problem of the commuters of buses plying the route DJLA-Bacolod and vice-versa regarding scarcity of buses operating in the said route especially after 5 o'clock in the afternoon onwards;

WHEREAS, during the Committee Meeting of the Committee on Laws, Rules, Procedures and Good Governance last March 3, 2015 this matter was taken up and after due consultation with the presidents of BACTODA, CAPTODA and PBLTODA and all other resource persons it was found out that this problems resulted from the fact that blue top tricycles are taking passengers of buses which results in the bus operators to cut down their number of trips due to scarcity of passengers;

WHEREAS, after due consultation with the resource persons then present it was found out that the best solution to this problem is to suspend the one-way-in, one-way-out policy in so far as the highway from Brgy. Don Jorge L. Araneta to Brgy. Poblcaion and vice-versa with certain qualifications;

WHEREAS, after a thorough deliberation, the members of this Honorable Body is of the consensus to suspend the one-way-in one-way-out policy as in so far as the blue top tricycles with qualifications;

NOW, THEREFORE, upon motion of SP Member Allan C. Galunan, duly seconded by SP Member Cleo F. Gaudite, the Sangguniang Panlungsod

RESOLVED, as it is hereby resolved, to suspend the one-way-in one-way-out policy as in so far as the blue top tricycles, namely: Members of BACTODA, CAPTODA and PBLTODA covering the highway from Don Jorge L. Araneta to Poblacion and vice versa with qualifications.

RESOLVED ALSO, that blue top members residing in Brgys. Pacol and Bagroy shall be exempted from the application of this resolution only up to that portion of the highway in Brgy. Road in Brgy. Caridad while after this limit shall be considered punishable as out of route under Ordinance No. 13-07, Series of 2013;

RESOLVED ALSO, that blue top members residing in Brgys. Caridad and Sagasa shall be allowed to load up to three (3) passengers only while overage shall be penalized as violation of existing ordinance;

RESOLVED FURTHER, that all exemption shall be granted only upon proper application filed with the Bago City PNP – Traffic Management Unit which may grant said application after due consideration and thereafter, assign a color-coded sticker;
