RESOLUTION NO. 15-103

RESOLUTION REQUESTING THE NATIONAL OFFICE OF THE BUREAU OF FIRE PROTECTION (BFP) THROUGH ITS REGIONAL OFFICE, TO CREATE A SUB-FIRE STATION IN BARANGAY MA-AO, BAGO CITY, NEGROS OCCIDENTAL.

WHEREAS, several fire incidents had happened in Barangay Ma-ao, the most costing P1.8 Million in damage to fish stalls in Barangay Ma-ao Public Market;

WHEREAS, the nearest fire station from the incident area is Bago City Fire Station which is twenty-two (22) kilometers away that will take a maximum of thirty (30) minutes for the fire engine to reach the area;

WHEREAS, to remedy the situation, in order to respond quickly to fire calls not only in Barangay Ma-ao but also the neighboring barangays, there is a need to have a sub-fire station in Barangay Ma-ao, Bago City;

NOW, THEREFORE, upon motion of SP Member Sergio T. Piansay, unanimously seconded by SP Members present, the Sangguniang Panlungsod

RESOLVED, as it is hereby resolved, to request the National Office of the Bureau of Fire Protection (BFP) through its Regional Office, to create a sub-fire station in Barangay Ma-ao, Bago City, Negros Occidental.
