RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A PROJECT PROPOSAL AND MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE PROVINCIAL GOVERNMENT OF NEGROS OCCIDENTAL AND THE CITY GOVERNMENT OF BAGO FOR A FINANCIAL ASSISTANCE FOR THE ENHANCEMENT OF "ONE BARANGAY ONE PRODUCT" FOR THE FIFTEEN BARANGAYS IN THE CITY OF BAGO.
