RESOLUTION APPROVING THE APPLICATION FOR PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE OF THE SUBDIVISION PROJECT OF CARMELA VALLEY AGRICULTURAL CORPORATION SITUATED AT BARANGAY NAPOLES, THIS CITY, CONTAINING A TOTAL AREA OF ONE HUNDRED TWENTY THOUSAND THREE HUNDRED SIXTY ONE (120,361) SQUARE METERS INTO SEVEN HUNDRED SIXTEEN (716) SALEABLE LOTS.

WHEREAS, in an endorsement letter dated June 18, 2015 from the Honorable City Mayor, addressed to this body, concerning the request of Engr. Deny L.
