RESOLUTION APPROVING THE INCREASE OF THE OVERLOAD HOURLY RATE BASED ON THE ACADEMIC QUALIFICATIONS OF INSTRUCTORS OF THE BAGO CITY COLLEGE: BACCALAUREATE DEGREE FROM P60/HR. TO P100/HR.; WITH MASTER'S DEGREE FROM P80/HR. TO P150/HR. AND DOCTORATE DEGREE FROM P100/HR. TO P250/HR. EFFECTIVE JULY 15, 2015.

WHEREAS, Indorsement letter dated July 8, 2015 from the Honorable City Mayor, respectfully referred to this Honorable body, the request for approval of Resolution No. 5, series of 2015 of the Board of Trustees, Bago City College, entitled: "Resolution Approving the Increase of the Overload Hourly Rate based on the Academic Qualifications of the Instructors: Baccalaureate Degree from P60/hr. to P100/hr.; with Master's Degree from P80/hr. to P150/hr. and Doctorate Degree from P100/hr. to P250/hr. effective 1st Semester of Academic Year 2015-2016;
