WHEREAS, further review reveals that it was not Ordinance No. 11-02 which is in point but rather Ordinance No. 230, Series of 1970, as amended particularly Rule V, Paragraph 1, (f), in relation to Rule XII, (g) thereof, as amended by Ordinance No. 141, Series of 1980;
