**RESOLUTION AMENDING SANGGUNIANG PANLUNGSOD RESOLUTION NO. 15-180 TO READ AS FOLLOWS: "RESOLUTION APPROVING THE INCREASE OF THE HOURLY RATE BASED ON THE ACADEMIC QUALIFICATIONS OF INSTRUCTORS OF THE BAGO CITY COLLEGE: BACCALAUREATE DEGREE FROM P60/HR. TO P100/HR.; WITH MASTER'S DEGREE FROM P80/HR. TO P150/HR. AND DOCTORATE DEGREE FROM P100/HR. TO P250/HR. EFFECTIVE JULY 15, 2015.**

**WHEREAS**, letter dated July 21, 2015 from Gorgonio T. Parroco, PhD., College Administrator, Bago City College, respectfully endorsed to this Honorable body for amendment of Sangguniang Panlungsod Resolution No. 15-180;

**WHEREAS**, per review of the Accounting Department and in concurrence with the Bago City College Academic Committee, the word "overload" is inappropriate as this term negates the basic and initial load of 24 units;

**WHEREAS**, Resolution No. 15-180 is hereby recommended to be amended whereby the word "overload" is to be deleted from the title as well as in the subsequent paragraphs;

**WHEREAS**, after a thorough deliberation on the matter, it was the consensus of this August Body to amend said resolution;
