RESOLUTION NO. 15-214

RESOLUTION SUSPENDING SECTION 4, PARAGRAPH A AND B OF ORDINANCE NO. 01, SERIES OF 2001, ENTITLED: "AN ORDINANCE REGULATING FISHING AND/OR FISHERIES IN THE CITY OF BAGO, PROVINCE OF NEGROS OCCIDENTAL, AND FOR OTHER PURPOSES", IN SO FAR AS THE RESIDENTS OF BACOLOD CITY ONLY ARE CONCERNED.

WHEREAS, during the Committee Meeting of the Committee on Agriculture last July 15, 2015, it was discussed that Bacolod City does not issue a permit to fishermen of Bago City;

WHEREAS, it was considered that Section 4, paragraph a and b of Ordinance No. 01, Series of 2001 as amended be revised to exclude residence of Bacolod City from those qualified to be granted fishing permit under the said ordinance;

WHEREAS, while the Sangguniang Panlungsod is still on the process of amending of Section 4, paragraph a and b of Ordinance No. 01, Series of 2001, there is an urgent need to temporarily suspend the provisions of said ordinance in order to immediately address the issue;

WHEREAS, after a thorough deliberation on the matter, it was the consensus of this August Body to suspend Section 4, paragraph a and b of Ordinance No. 01, Series of 2001.

NOW, THEREFORE, upon motion of SP Member Allan C. Galunan, duly seconded by SP Member Donald A. Alvarez, the Sangguniang Panlungsod

RESOLVED, as it is hereby resolved, to suspend Section 4, paragraph a and b of Ordinance No. 01, Series of 2001, entitled: "An Ordinance Regulating Fishing and/or Fisheries in the City of Bago, Province of Negros Occidental, and for Other Purposes", in so far as the residents of Bacolod City only are concerned.
