**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF HEALTH – REGIONAL OFFICE VI FOR A FINANCIAL ASSISTANCE TO COVER THE MANAGEMENT AND UTILIZATION EXPENSES OF THE COMMUNITY HEALTH TEAMS AMOUNTING TO EIGHT HUNDRED FIFTY TWO THOUSAND PESOS (PHP 852,000.00).**

**WHEREAS**, letter dated August 18, 2015 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and the Department of Health – Regional Office VI for a financial assistance to cover the management and utilization expenses of the Community Health Teams amounting to Eight Hundred Fifty Two Thousand Pesos (Php 852,000.00);
