RESOLUTION NO. 15-224

RESOLUTION AMENDING SANGGUNIANG PANLUNGSOD RESOLUTION NO. 15-158 TO READ AS FOLLOWS: "RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE DEPARTMENT OF LABOR AND EMPLOYMENT REGIONAL OFFICE VI AND THE CITY GOVERNMENT OF BAGO FOR THE IMPLEMENTATION OF THE DOLE – INTEGRATED LIVELIHOOD AND EMERGENCY EMPLOYMENT PROGRAM, PARTICULARLY THE COMPOSTING AND ESTABLISHMENT OF THE COMPOSTING FACILITY, COOKERY NC 11, BAMBOO ARTS AND CRAFTS, FRUITS AND VEGETABLES/ROOT CROPS PROCESSING, RECYCLED BAGS AND OTHER ITEMS, FASHION JEWELRIES AND OTHER ACCESSORIES, MEAT PROCESSING, AND RESIN ARTS AND CRAFTS".

WHEREAS, letter dated August 18, 2015 from the Honorable City Mayor, endorsed to this Honorable body for amendment of Sangguniang Panlungsod Resolution No. 15-158 dated June 18, 2015, which shall now be read as follows: "*Resolution authorizing the City Mayor to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the Department of Labor and Employment Regional Office VI and the City Government of Bago for the implementation of the DOLE – Integrated Livelihood and Emergency Employment Program, particularly the composting and establishment of the composting facility, cookery NC 11, Bamboo Arts and Crafts, Fruits and Vegetables/Root Crops Processing, Recycled Bags and other items, Fashion Jewelries and other Accessories, Meat Processing, and Resin Arts and Crafts*";
