TONGOY FOR THE DONATION OF A PARCEL OF LAND COVERED BY TCT NO. 093-2014000573, CONTAINING AN AREA OF TEN THOUSAND (10,000) SQUARE METERS MORE OR LESS LOCATED AT BARANGAY SAMPINIT, THIS CITY.**

**WHEREAS**, letter dated September 23, 2015 from the Honorable City Mayor, respectfully referred to this Honorable Body the intention of M.R.A. & Sons, Inc. represented by Jose Luis Leonard J.
