**WHEREAS**, letter dated October 19, 2015 from the Honorable City Mayor, Ramon D. Torres, respectfully referred to this Honorable Body for a passage of a resolution requesting the President, His Excellency Benigno S. Aquino III to declare, Friday, 19 February 2016, as a special (non-working) day in the City of Bago, Negros Occidental;

**WHEREAS**, 19<sup>th</sup> of February 2016 marks the 50<sup>th</sup> inauguration of the City of Bago as a chartered city and the 18<sup>th</sup> Babaylan Festival;
