RESOLUTION AMENDING RESOLUTION NO. 15-318 TO READ AS FOLLOWS: "RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND <u>AMONG</u> THE CITY GOVERNMENT OF BAGO, YUUSUKE KARASAWA ARCHITECTS AND ASUNARO FOUNDATION AND <u>VMA GLOBAL COLLEGE AND</u> <u>TRAINING CENTERS</u> FOR THE CONSTRUCTION OF A WOODEN DAYCARE CENTER AND PLAYGROUND AT BANTAYAN PARK, THIS CITY".
