RESOLUTION AMENDING RESOLUTION NO. 15-318 TO READ AS FOLLOWS: "RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, YUUSUKE KARASAWA ARCHITECTS AND ASUNARO FOUNDATION AND VMA GLOBAL COLLEGE AND TRAINING CENTERS FOR THE CONSTRUCTION OF A WOODEN DAYCARE CENTER AND PLAYGROUND AT BANTAYAN PARK, THIS CITY".
