RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, CITY GOVERNMENT OF BAGO, DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT, BAGO CITY POLICE OFFICE – PHILIPPINE NATIONAL POLICE, ASSOCIATION OF BARANGAY CAPTAINS, ASOSASYON SANG MGA IMOL NGA MANGUNGUMA SA TALOC BAYBAY (AIMATABA) AND FRIENDS OF THE HIGHLANDS COOPERATIVE FOR THE CREATION OF BAGO CITY MULTI-SECTORAL FOREST PROTECTION COUNCIL.
