RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN CENTRAL NEGROS ELECTRIC COOPERATIVE, INCORPORATED AND THE CITY GOVERNMENT OF BAGO FOR THE INSTALLATION FOR EXTENSION OF 2-SPANS SINGLE PHASE PRIMARY LINE, 1-37.5 KVA DISTRIBUTION TRANSFORMER WITH ACCESSORIES AND SECONDARY METERING AND STRINGING OF SERVICE WIRE FOR FARMERS TRAINING CENTER AND SLAUGHTER HOUSE SITUATED AT BARANGAY LAG-ASAN, BAGO CITY.
