## **RESOLUTION NO. 16-063**

RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR TO UTILIZE FOR THE 50<sup>™</sup> CHARTER ANNIVERSARY THE AMOUNT OF ONE MILLION NINE HUNDRED SEVEN THOUSAND SIX HUNDRED TWENTY FIVE PESOS AND FIVE CENTAVOS (P1,907,625.05) REPRESENTING THE UNEXPENDED BALANCES OF VARIOUS FINANCIAL ASSISTANCE RECEIVED BY THE CITY IN ITS TRUST FUND AND NO LONGER NEEDED FOR THE SPECIFIC PURPOSE THEY WERE INTENDED FOR AND THUS, CONSIDERED SAVINGS.
