RESOLUTION APPROVING RESOLUTION NO. 01, SERIES OF 2016 OF THE CITY DEVELOPMENT COUNCIL EXECUTIVE COMMITTEE, THIS CITY, ENTITLED: "RESOLUTION APPROVING THE FOLLOWING PROJECTS TO BE FUNDED UNDER THE CY 2014 AND CY 2015 UNPROGRAMMED INTERNAL REVENUE ALLOTMENT IN THE AMOUNT OF SEVENTEEN MILLION SEVEN HUNDRED FIFTY TWO THOUSAND TWO HUNDRED EIGHTY THREE PESOS (PHP 17,752,283.00): (1) BACKFILLING OF BANTAYAN PARK (LOT PURCHASED FROM OBANDO FAMILY)-PHP2,150,000.00; (2) RE-GRAVELLING OF MA-AO-MAILUM ROAD (LIBERTAD)-PHP600,000.00; (3) RE-GRAVELLING OF BACONG ROAD-PHP1,000,000.00; (4) CONCRETING OF BUSAY ROAD-PHP1,500,000.00; (5) CONCRETING OF BINUBUHAN ROAD-PHP1,500,000.00; (6) CONCRETING OF LAG-ASAN ROAD-SAN ESTEBAN-(PHASE 1)-PHP1,500,000.00; (7) CONCRETING OF TALOC-CAMINGAWAN ROAD-PHP1,000,000.00; (8) CONCRETING OF TALOC HIGH SCHOOL ROAD-PHP2,000,000.00; AND (9) WIDENING OF MA-AO ROAD (IN FRONT E/S & BARANGAY HALL)-PHP1,000,000.00, IN THE TOTAL AMOUNT OF TWELVE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (PHP 12,250,000.00).
