**RESOLUTION APPROVING THE REDUCTION OF TRICYCLE FARES FOR THE CITY PROPER AREA (POBLACION, BALINGASAG AND LAG-ASAN ROUTE) FROM THE PRESENT RATE TO THE OLD RATE AS CONTAINED IN ORDINANCE NO. 11-05, SERIES OF 2011.**

**WHEREAS**, noted in national news and other forms of mass media is the significant decrease of gasoline and diesel products in the country;

**WHEREAS**, this significant decrease of gasoline and diesel products is followed by clamor of the residents of Bago City that tricycle fares be reduced to ease their transportation costs;

**WHEREAS**, to show concern over the welfare of its constituents, and after a thorough deliberation on the matter, it is the consensus of this assembly to reduce the tricycle fares for the City Proper Area (Poblacion, Balingasag and Lag-asan Route) from the present rate to the old rate as contained in Ordinance No. 11-05, Series of 2011.
