RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN AN AGREEMENT OF SUBDIVISION TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND CATALINA MODESTO, FOR A PARCEL OF LAND DONATED TO THE CITY GOVERNMENT OF BAGO, WITH AN AREA EQUIVALENT TO ONE (1) HECTARE, MORE OR LESS, AS ANNOTATED UNDER ENTRY NO. 36481 COVERED UNDER TCT NO. 15814.

WHEREAS, letter dated February 9, 2016 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in an Agreement of Subdivision to be executed by and between the City Government of Bago and Catalina Modesto, for a parcel of land donated to the City Government of Bago, with an area equivalent to One (1) Hectare, more or less, as annotated under entry no. 36481 covered under TCT No. 15814;
