RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN AN AGREEMENT OF SUBDIVISION TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND INOCENTES DE LA RAMA, INC. FOR A PARCEL OF LAND DONATED TO THE CITY GOVERNMENT OF BAGO, WITH AN AREA EQUIVALENT TO TWO (2) HECTARES, MORE OR LESS, AS ANNOTATED UNDER ENTRY NO. 2015000692 COVERED UNDER TCT NO. 13026.
