## **RESOLUTION NO. 16-095**

RESOLUTION AMENDING RESOLUTION NO. 16-070 TO READ AS FOLLOWS: "RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, THE CITY GOVERNMENT OF BAGO AND THE IDENTIFIED CIVIL SOCIETY ORGANIZATION IN THE CITY FOR THE IMPLEMENTATION OF BOTTOM UP BUDGETING (BUB) FOR VARIOUS PROJECTS IMPLEMENTED IN THE CITY".
