RESOLUTION APPROVING THE APPLICATION FOR PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE OF FRANK JUDE FUENTEBELLA, FOR PROPOSED TERRAZAS SUBDIVISION PROJECT, SITUATED AT BARANGAY TABUNAN, THIS CITY, HAVING AN AREA OF SEVENTY ONE THOUSAND TWO HUNDRED SIX (71,206) SQUARE METERS, CONTAINING FOUR HUNDRED THIRTY THREE (433) SUBLOTS.
