RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT, ROAD BOARD SECRETARIAT AND THE CITY GOVERNMENT OF BAGO FOR THE ESTABLISHMENT OF THE PROVINCIAL AND CITY ROADS LOCATIONAL REFERENCING SYSTEM AND CONDUCT OF ROAD INVENTORY.
