RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND NATIONAL FOOD AUTHORITY FOR ALLOWING THE CITY TO PURCHASE RICE ON CREDIT FOR RELIEF OPERATIONS DURING CALAMITIES.
