RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE DEED OF DONATION TO BE EXECUTED BY AND BETWEEN CHILDFUND PHILIPPINES, INCORPORATED, HEREIN AFTER CALLED THE DONOR, AND THE CITY GOVERNMENT OF BAGO, HEREIN AFTER CALLED DONEE, FOR THE DONATION OF ASSETS WHICH WILL BE USED FOR THE CONTINUATION OF THE PROGRAM ON CHILD LABOR OR PROGRAM FOR CHILDREN.

WHEREAS, in a letter dated April 4, 2016, addressed to the Honorable Ramon D. Torres, City Mayor, Bago City, from ABK3 LEAP ChildFund Philippine Bacolod Sub-Office, indicated their intention to donate various assets to this local government unit as part of their project to combat Child Labor in the country will come to an end on June 30, 2016;

WHEREAS, a Deed of Donation through a Memorandum of Agreement between the Local Government of Bago and ChildFund Philippines, Incorporated is required to formalize the agreement;
