RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN PHILIPPINE HEALTH INSURANCE CORPORATION AND THE CITY GOVERNMENT OF BAGO FOR A COLLECTION AND REMITTANCE AGREEMENT IN ACCORDANCE WITH THE IMPLEMENTING RULES AND REGULATIONS OF THE NATIONAL HEALTH INSURANCE ACT (R.A. 7875) AS AMENDED BY R.A. 9241.
