## **RESOLUTION NO. 16-208**

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN DEED OF PERPETUAL USUFRUCT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND DEPARTMENT OF EDUCATION, BAGO CITY FOR THE USE OF A PARCEL OF LAND AS SCHOOL SITE FOR ITS K+12 PROGRAM AT BARANGAY SAMPINIT, THIS CITY.
