RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND NEGROS ISLAND REGION TRAINING CENTER (NIRTC) 18, NATIONAL TRAINING INSTITUTE (NPTI) – PHILIPPINE PUBLIC SAFETY COLLEGE (PPSC) FOR THE TEMPORARY USE OF THE ATHLETES' QUARTER, MESSHALL, DUGOUT AND TRACK AND FIELD OVAL LOCATED AT THE MANUEL Y. TORRES MEMORIAL SPORTS CENTER IN THE CONDUCT OF THEIR TRAINING ACTIVITIES.
