RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND BUREAU OF FISHERIES AND AQUATIC RESOURCES FOR PROVIDING FUNDS TO THE CITY AMOUNTING TO ₱3,000,000.00 FOR THE IMPROVEMENT/ESTABLISHMENT OF PORTS/WHARFS IN THE CITY.
