WHEREAS, it has come to the attention of the August Body that President Rodrigo Roa Duterte is poised at signing an Executive Order dissolving the Negros Island Region (NIR 18);

WHEREAS, this August body is saddened by this pronouncement considering that the creation of Negros Island Region has renewed the sense of unity between Negros Occidental and Negros Oriental;

WHEREAS, the creation of NIR 18 will enhance the rapid socio-economic growth and development in the newly created region besides the speedy delivery of basic services, the promotion of equitable distribution of resources for the region and the easy transaction with government offices by its populace;

WHEREAS, reason dictates that NIR 18 should be retained for its obvious advantages culturally, economically, socially and practically;

WHEREAS, this August body is of the consensus to support the retention of NIR 18.
