RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A LOAN AGREEMENT AND OTHER RELATED DOCUMENTS IN THE AMOUNT OF FIFTY MILLION PESOS (PHP50,000,000.00) TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE PHILIPPINE VETERANS BANK – BACOLOD CITY TO FINANCE THE VARIOUS PROJECTS OF THE CITY OF BAGO.

WHEREAS, letter dated November 2, 2016 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City Government of Bago in a Loan Agreement and other related documents in the amount of Fifty Million Pesos (Php50,000,000.00) to be executed by and between the City Government of Bago and the Philippine Veterans Bank – Bacolod City to finance the various projects of the City of Bago;
