## **RESOLUTION NO. 16-307**

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FOR PROVIDING A WAREHOUSE/FACILITY FOR STOCKPILING OF FOOD AND NON-FOOD COMMODITIES TO BE USED EXCLUSIVELY DURING CALAMITIES AND DISASTERS.
