RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FOR PROVIDING A WAREHOUSE/FACILITY FOR STOCKPILING OF FOOD AND NON-FOOD COMMODITIES TO BE USED EXCLUSIVELY DURING CALAMITIES AND DISASTERS.

WHEREAS, letter dated October 25, 2016 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and the Department of Social Welfare and Development for providing a warehouse/facility for stockpiling of food and non-food commodities to be used exclusively during calamities and disasters;
