RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE CONTRACT OF LEASE TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND RLX CONSTRUCTION SUPPLY EQUIPMENT AND SERVICES FOR THE LEASE OF EQUIPMENT (BACKHOE) EXCLUSIVELY FOR DEMOLITION/EXCAVATION AND CLEARING OF SITE FOR THE PROPOSED CONSTRUCTION OF TWO BARREL BOX CULVERT AT BEGONIA, BARANGAY MA-AO, THIS CITY.
