RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE CITY GOVERNMENT OF BAGO, VILLANUEVA CLINICAL LABORATORY & POLYCLINIC AND NEW BLOOD CHANNEL TO PROVIDE THEIR SERVICES AS LICENSED CLINICAL LABORATORIES TO CATER REQUEST FOR LABORATORY TESTS/EXAMINATIONS WHICH ARE NOT AVAILABLE AT THE BAGO CITY HOSPITAL.

WHEREAS, letter dated November 28, 2016 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and among the City Government of Bago, Villanueva Clinical Laboratory & Polyclinic and New Blood Channel to provide their services as licensed clinical laboratories to cater request for laboratory tests/examinations which are not available at the Bago City Hospital;
