RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF LABOR AND EMPLOYMENT REGIONAL OFFICE XVIII MANIFESTING INTENTION TO AVAIL THE DOLE INTEGRATED LIVELIHOOD AND EMERGENCY PROGRAM, SPECIFICALLY THE TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED WORKERS PROGRAM.
