WHEREAS, in the interest of public safety and welfare wherein fatal traffic accidents have occurred on our national roads and highways caused by reckless drivers and non-observance of traffic rules and regulations, there is an urgent need for the renewal of the deputization of Bago PNP Members and Traffic Enforcers of Bago City, Negros Occidental;
