RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN A MEMORANDUM OF UNDERSTANDING (MOU) MADE AND ENTERED INTO BY AND AMONG THE CITY GOVERNMENT OF BAGO, NATIONAL IRRIGATION ADMINISTRATION (NIA), FEDERATION OF IRRIGATORS ASSOCIATION, INC., PROVINCE OF NEGROS OCCIDENTAL, CITY OF BACOLOD, CITY OF LA CARLOTA, MUNICIPALITY OF MURCIA, MUNICIPALITY OF VALLADOLID, MUNICIPALITY OF SAN ENRIQUE, MUNICIPALITY OF PULUPANDAN, PHILRICE, NATIONAL FOOD AUTHORITY, LAND BANK OF THE PHILIPPINES, QUEDAN CORPORATION AND THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES/PROVINCIAL ENVIRONMENTAL AND NATURAL RESOURCES OFFICE IN THE PLANNING, MANAGEMENT AND OPERATION OF BAGO RIVER IRRIGATION SYSTEM THROUGH THE SYSTEM MANAGEMENT COMMITTEE (SMC).
