RESOLUTION APPROVING BARANGAY ORDINANCE NO. 10-05, SERIES OF 2010 OF BARANGAY MA-AO, THIS CITY, ENTITLED: "AN ORDINANCE DECLARING A PORTION OF BONIFACIO STREET (TH STREET EAST OF THE PUBLIC MARKET THAT LEADS TO HDA. FERMINA) AS A ONEWAY STREET IN ORDER TO ENSURE THE SMOOTH FLOW OF TRAFFIC AND TO MINIMIZE ACCIDENTS IN THE AREA".

WHEREAS, in a letter dated January 12, 2011 from the Punong Barangay of Barangay Ma-ao, this city, address to this Honorable body, is the Barangay Ordinance No. 10-05, series of 2010, for review;
