JOCSON, MD, DPBA TO PRACTICE HIS PROFESSION FOR A FEE AS PRIVATE PRACTICING ANESTHESIOLOGIST AT BAGO CITY HOSPITAL IN COORDINATION WITH THE MEDICAL OFFICERS/SURGEONS OF THE HOSPITAL.**
