(NODRF) FOR A FINANCIAL ASSISTANCE IN THE MAINTENANCE OF THE MULTI-DISCIPLINARY TREATMENT MODALITY OF THE NEGROS OCCIDENTAL DRUG REHABILITATION CENTER.**
